Certification is mandatory for the category of Water Treatment. According to the NT Public Health Act Legislation

Certification of a Water Supply Foreperson:

21. (1) Subject to subsection (2), a water supply foreperson must be certified to operate the class of water supply system or part of the system he or she will be operating, controlling and managing on a daily basis, in accordance with the certification requirements approved by the Chief Public Health Officer.

The Government of the Northwest Territories Water and Wastewater Certification Program requires that certified operators submit two (2.0) Continuing Education Units (CEUs) every two years to maintain Certification in the category they are certified in.

Water and Wastewater System Operators operating water treatment, water distribution, wastewater treatment and wastewater collection systems and their facilities and who have obtained certification must maintain certification by participating in continuing education on an ongoing basis.

CEUs are organized educational activities that demonstrate an operator is remaining current in the water and/or wastewater field; examples include attending relevant conferences, classroom training or on the job training.

A Continuing Education (CEU) Log Book is important for operators to keep. With the log book the operator can record all training activities that may be eligible for CEUs. Operators should keep their training log current and have trainers/instructors initial when training is completed.

Continuing Education Units (CEUs) are awarded based on the amount of training and contact time an operator participates in. One (1) hour of training is equivalent to 0.1 of a CEU. Ten (10) hours is equivalent to one (1) full CEU.

CEUs can be submitted by faxing or by scanning and emailing the completed (and signed) page or pages of the CEU Log Book. CEUs should be submitted once/per year and at minimum once every two years. You must include whatever back up is available for your CEU submission i.e. certificate awarded for course completion, attendance record etc.
